## **ORDINANCE NO. 2015.1**


AN ORDINANCE ADOPTING THE FINAL MILLAGE RATE FOR THE  
EAST NICEVILLE FIRE DISTRICT  
FOR THE CALENDAR YEAR 2015

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BOARD OF THE  
EAST NICEVILLE FIRE DISTRICT, THAT:


- SECTION 1.** The Governing Board does hereby adopt its final millage rate of 2.7000 mils to be levied for the General Fund upon all real property within the boundaries of the above named taxing district.
- SECTION 2.** THE FINAL LEVY OF 2.7000 MILS WILL RESULT IN A 12.45% INCREASE OVER THE ROLLED BACK RATE OF 2.4011 MILS.
- SECTION 3.** This final millage rate of 2.7000 mils for the General Fund is levied for calendar year 2015, to fund expenses for the fiscal year commencing 1 October 2015 and ending 30 September 2016.

EAST NICEVILLE FIRE DISTRICT


FOR THE FISCAL YEAR COMMENCING ON 1 OCTOBER 2015 AND ENDING ON 30 SEPTEMBER 2016


NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BOARD OF THE  
EAST NICEVILLE FIRE DISTRICT, THAT:


- SECTION 1.** The proposed expenditure in the Final Budget is \$900,865.00. The budget is based on taxable value of real property of \$301,718,622.00 and anticipated non-ad Valorum revenues of \$39,620.00 and a budget carry-over of \$79,576.00.
- SECTION 2.** The Final Budget is approved and shall become effective at the beginning of the 2015-16 fiscal year, and the taxing authority's funds may be expended commencing on 1 October 2015 and ending on 30 September 2016.
- SECTION 3.** Funds budgeted against fiscal year 2014-15 expenses and not expended during the current fiscal year may be used and expended during subsequent fiscal years.
